

BESS project financing options in Norway 2026



Overview

Today, we are seeing non-recourse project finance for 600+ MW portfolios, mezzanine debt entering the capital stack, and public banks co-financing with private lenders. For developers, asset managers, and financiers alike, this is a call to sophisticate how BESS projects are packaged and financed. How do I secure debt for Bess & hybrid projects?

Securing debt for BESS and hybrid projects requires a "bankable" revenue forecast from lenders preferred consultants. Developers need their own flexible modelling tools to optimise project design and achieve more favourable financing terms.

Which Bess projects are in the pipeline in Sweden?

Most BESS projects in the pipeline in Sweden are 1-hour systems, with the business case still very much centred around ancillary service markets. One of the first European-owned gigafactories for battery cell production, Northvolt's Ett was built in Sweden, and the company is collaborating with Volvo to build the country's second site.

How can Bess obtain contracted revenue?

BESS can obtain contracted revenue through: This means that project modelling software used by developers should be able to incorporate these kinds of commercial structures. It is important to note that the lenders will look closely at the capacity of the off-takers to pay for the contract.

What are the barriers to Bess project financing?

Emily Sidhu, director in the banking and investment team at UK Infrastructure Bank (UKIB), explains that the main barrier to the project financing of BESS projects relates to revenues.

Is the Bess offtake contract market growing in Europe?

The market for BESS offtake contracts in Europe is still relatively nascent and

illiquid relative to the mature RES PPA market. However conditions are improving quickly as BESS growth gathers pace. A key theme in BESS offtake contract evolution across Europe is an increased focus on downside protection after 2023-24 revenue decline.

How has Bess changed over the last year?

Despite a decline in BESS revenues across 2023-24, competition amongst offtake providers has risen significantly across the last year. This is good news for BESS investors as it is pushing down fees and driving innovation in offtake contract structures. In this article we look at: Evolution of debt financing for BESS.

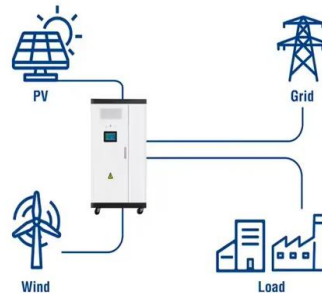
