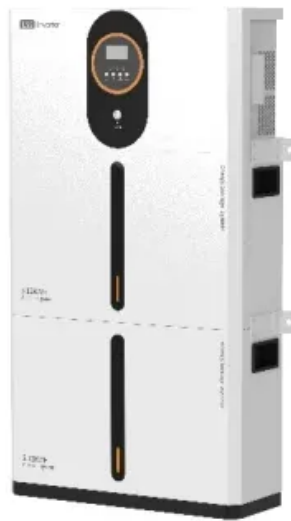


BESS tender price in Greece 2025



Overview

According to the schedule, bidding is set to be completed by January 27, 2025. A final decision on the successful projects is due to be available on March 13, 2025. The BESS tender, launched in November, will provide subsidies of EUR 200,000 (USD 210,146) per MWh.

The average subsidy price in the third auction exercise came at €52589.16/MW/year. The lowest successful bid stood at €43927/MW/year, concerning a 25 MW/100 MWh project in the Western Macedonia region. The highest awarded subsidy came at €58773/MW/year and refers to a 7.9 MW/31.6 MWh project.

The average bidding price (Reference Tariff), in €/MW/year of the 1st BESS Tender was 49,748.18€ and for the 2nd BESS Tender was in the range of 47,680.36 euros/MWh/year. BESS selected through the 1st BESS Tender secured an investment grant of 200,000.00 €/MW while projects selected through the 2nd.

As for the average price, it landed at EUR 52,589.16 per MW per year in the auction. The lowest offer was EUR 43,927 per MW, by HELLENiQ Renewables, while the highest was EUR 58,773 per MW, by Plain Solar. The average prices in the first and second auctions were EUR 49,748 per MW and EUR 47,680 per.

The bids were priced at between EUR 34,000 (USD 37,475) per MW and EUR 64,000 per MW and were capped at EUR 115,000 per MW per year. The lowest offer was launched by Helleniq Energy, while Intra Energy placed the highest bid. The selected developers will receive a grant of up to EUR 200,000 per MW.

Greece's Regulatory Authority for Energy (RAE) has successfully allocated

411.8 MW of projects from 93 proposals, surpassing the 400 MW target for the first BESS tender. 12 projects from 7 developers will receive financial aid for investment and operation over a 10 year period. Projects are.

National Bank of Greece S.A. signed a loan agreement with ELSEWEDY ELECTRIC SAE for the financing of the construction of the first Battery Energy Storage System (BESS) in Greece, which was selected in the first Auction held by the regulatory Authority for Energy, Waste and Water (RAEWW) in July. Greece's latest auction has awarded subsidies to 188.9 MW of standalone, front-of-the-meter, utility-scale battery energy storage. The auction was the third and final edition of a battery storage subsidy program launched in 2023, with the country now turning its focus towards a new 4.7 GW unsubsidized BESS scheme.

When will Greece launch a second call for tenders?

Does Greece have a Bess subsidy program?

Moving forward, Greece is abandoning subsidizing BESS via auctions. Instead, the country has recently launched a new program for 4.7 GW of unsubsidized BESS which will be offered priority grid connections on a merchant basis without subsidy support. Will raaey support Bess in Greece?

The first such tender for award of CAPEX and OPEX support to BESS organized by RAAEY, is a critical step for the deployment of the first utility scale BESS in Greece. 95 offers in total have been received amounting to approximately 3.3 GW, which contest the 400 MW quota of this first phase.

How many MW of Bess will be awarded?

In total 1000 MW of BESS will receive the support mechanism and the plan is to be awarded with two more phases culminating December 2023. CAPEX of the BESS plant is of the greatest importance regarding the commercial assessment of the investment.

How much does a Bess plant cost?

CAPEX of the BESS plant is of the greatest importance regarding the commercial assessment of the investment. With BESS system prices being high today (with costs for Lithium-Ion BESS ranging from 550.000 EUR/MW to 650.000 EUR/MW for the future).
