How much does Bess cost?

BloombergNEF recently noted a global average price for BESS (without PCS or EMS) of US\$125 per kWh, for example. Kubik suggested the tender's requirements implied it covered an AC block solution. Energy-Storage.news looked at the move towards PCS-integrated AC blocks in a recent article (Premium access).

How much did CGN new energy pay for Bess?

In January, CGN New Energy procured 4.5 GWh of grid-forming BESS and 6 GWh of grid-following BESS. In the first group, the bids averaged CNY 0.6067/Wh (\$84/kWh), while in the second one the average was CNY 0.489/Wh (\$67/kWh).

How much does LFP Bess cost per kWh?

Basically the sigmoid of cost curve reduction had reached its shift in the curve to flattening again. And now LFP BESS are coming in at an average of \$66 per kWh. Of course, that's in China.
