How do I buy a photovoltaic system?

As a rule, you must apply for a subsidy for a photovoltaic system or a battery storage system before buying the system. You must also apply for a loan from the KfW before purchase. As soon as your application has been received and approved, you can usually have the system installed.

Will Germany tax rooftop photovoltaic systems in 2022?

Tax exemption and refund: According to the 2022 Annual Tax Law approved by the German government, starting from 2023, Germany will exempt income tax and corresponding value-added tax for eligible rooftopphotovoltaic systems.




