

Commercial energy storage tender price in Czech 2026



Overview

Both firm and variable price component for gas storage facilities for 2026 will be set by the Energy Regulatory Office in the new price decision in November 2025.

The firm annual prices for booked firm transmission capacity for the entry and exit points of virtual gas storage are set by the Price Decision No. 10/2024 dated.

The variable price component applies only to exit points of the transmission system to the virtual gas storage and according to the Article 8.1 of the Price Decision No.

The subsidy increases to cover up to 75% of costs for community projects. But what we noticed at Wattstor is that Czech businesses are investing in renewable projects even in the absence of subsidies, because they have realised the strong business case for generating clean energy on site.

What incentives are there for onsite generation in the Czech Republic?

At the same time, stakeholder and regulatory pressure encouraged Czech

organisations to invest in renewable power. There are several EU incentives to spur the growth of onsite generation. For example, the Modernisation Fund supports investments in energy efficiency, storage, network upgrades and the re-skilling of workers.

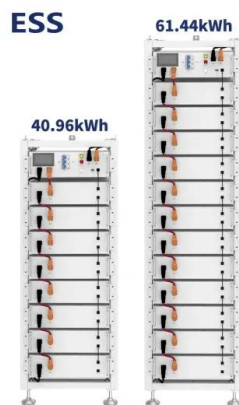
