The Dominican Republic has launched its first tender for up to 600 MW of solar and wind capacity with mandatory storage, requiring all projects to include battery systems capable of at least four hours of backup. Winning projects, ranging from 20 MW to 300 MW, will sign long-term dollar-denominated.

Minister Joel Santos highlighted that 300 megabytes of storage are required by 2027.

During the “Energy Sector Reform” Forum organized by the Dominican Association of the Electric Industry (ADIE) and the Technological Institute of Santo Domingo (INTEC), Edward Veras, executive director of the National Energy Commission (CNE), emphasized the Dominican Republic’s progress in energy.

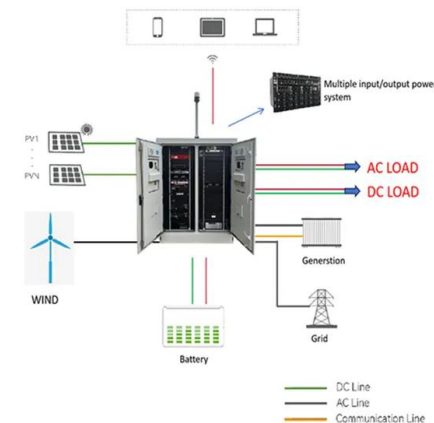

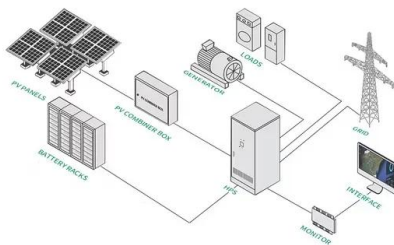

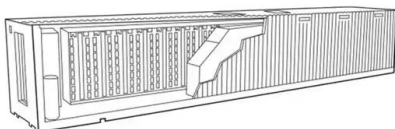
