Does Malaysia need ESG reporting?

Pressure to ensure the Social and Governance aspects of ESG are met is also coming from the government. With the introduction of frameworks such as i-ESG and both Bursa and Capital Markets Malaysia requiring ESG reporting, all businesses in the supply chain must take their obligations in this regard more seriously.

What is the deadline for ESG adoption in Malaysia?

Deadline: December 31st 2025, or until funding runs out. Domestic Investment Accelerator Fund (DIAF) – ESG Adoption: The Malaysian Investment Development Authority (MIDA) offers tax incentives and funding for sustainability-related initiatives like energy efficiency, waste management, and renewable energy.

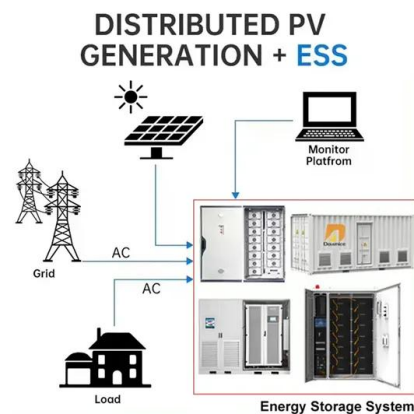
