What is a bulk energy storage implementation plan?

The Implementation Plan provides an operating framework for the program, with additional details to be provided in Bulk Energy Storage program solicitations.

When did NYSERDA submit the bulk energy storage program manual?

On June 12, 2025, NYSERDA filed the Bulk Energy Storage Program Manual [PDF] with the Public Service Commission. On April 18, 2025, NYSERDA submitted the Bulk Energy Storage Final Implementation Plan to the Public Service Commission. On March 21, 2025 the Commission issued an Order Approving Bulk Implementation Plan with Modifications [PDF].

What is New York's New energy storage goal and deployment policy?

On June 20, 2024, the New York Public Service Commission approved the Order Establishing Updated Energy Storage Goal and Deployment Policy [PDF]. The Order directs NYSERDA to issue three Requests for Proposals (RFP) for the new Bulk Energy Storage Program.

What is the bulk energy storage program?

The Bulk Energy Storage Program will use an innovative Index Storage Credit incentive, as established in the Order and modeled in part on the Renewable Energy Certificate (REC) and Offshore Wind Renewable Energy Credit (OREC) utilized in other NYSERDA programs.

How long should a bulk energy storage program be?

Addressing current and future duration needs is a critical design consideration of the Bulk Energy Storage program. According to Roadmap modeling, most deployments by 2030 are expected to be short duration, 4-hour resources.

When will NYSERDA send a response to the ISC standard form agreement?

Responses to the Draft ISCRFP25-1, Draft Bulk Energy Storage Program Manual, and Draft Appendix A were due to NYSERDA on Thursday, May 29, 2025. Responses to the Draft ISC Standard Form Agreement were due to NYSERDA on Thursday, June 5, 2025.

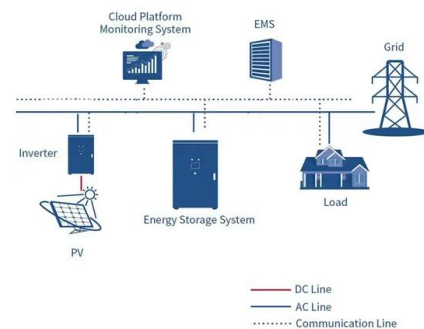

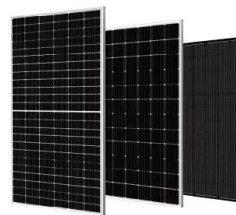
