According to the plea agreement, Siemens Energy's conduct resulted in losses of between \$65 million and \$150 million to the victims of the scheme, and the company faced a criminal penalty range of \$104 million to \$208 million under the U.S. Sentencing Guidelines. Siemens Energy received the low end of the range.

How long does FirstEnergy have to pay a penalty?

FirstEnergy President and CEO Brian Tierney said the company is pleased it was able to reach a settlement with the SEC, which said the company has to pay the penalty within 14 days or face interest charges.

Why did seewer pay \$230 million in penalties?


