Overview

How to design a benefits package for employees in Vietnam?

When designing a benefits package (C&B) for employees in Vietnam, there are benefits required by law that every company must provide to their employees. These are minimum legal requirements, including full insurance, annual leave, public holidays, and mandatory health check-ups.

1. Social Security.

Are employees entitled to statutory benefits in Vietnam?

In Vietnam, all full-time employees are entitled to statutory benefits, including employees on short-term contracts. What about independent contractors?

Independent contractors are classified differently to employees.

How do severance payments work in Vietnam?

Vietnamese labour law requires employers to provide severance payments to employees whose employment contracts are terminated where those employees have been regularly working for the employer for 12 months or more. The severance payment is equal to one-half of one month's wages for each year of employment.

What benefits can I offer my Vietnamese workforce?

Some of the most attractive benefits you can offer your Vietnamese workforce include: Vietnam's mandatory insurance contributions only cover health and unemployment. You can supplement these with personal and disability insurance, as well as additional perks and benefits.

How much do Vietnamese employees contribute to a trade union?

Additionally, Vietnamese employees who choose to join the trade union contribute an extra 1% of their gross salary. However, this employee contribution is capped at 180,000 VND. Note: When a company and its employees agree to establish a trade union, employees will be required to

contribute 1% of their gross salary to the trade union fund.






