This federal commitment will be funded by three vehicles: the Canada Infrastructure Bank (CIB), the Smart Renewables and Electrification Pathways Program (SREP) and the recently announced Clean Investment Tax Credits (ITCs). Who is responsible for implementing the 2030 Agenda in Canada?

While the Minister of Families, Children and Social Development has the overall responsibility to lead Canada's implementation of the 2030 Agenda, the Minister of International Development leads the advancement of Canada's responsibilities and its commitments to the SDGs in terms of foreign policy and international development.

Who is responsible for accelerating Canada's commitment to the 2030 Agenda?

To accelerate progress towards Canada's commitment to the 2030 Agenda, the Minister of Children, Families and Social Development was appointed to lead Canada's implementation of the 2030 Agenda in close collaboration with all other ministers and their departments.

What funding options are available for ERP projects?

Funding available: Projects can receive ERP funding up to 15% of eligible costs. Interest-free loans up to 15% of funding (max of \$5 million) are also available during the project period, up to 4 years. The program also offers advisory services to support skills and talent, health and safety and environmental plans.

How much money do wind and solar projects cost in Canada?

These projects represent at least \$33 billion of investment and are a key component of the largest build-out of wind and solar development in Canada



since the advent of Ontario's Green Energy Act.

How much ERP funding is available in BC?

ERP funding available: BC Employer Training Grant: Employers can receive up to \$300,000 per year under the program (April 1 to March 31). The Workforce Training Stream covers 60% of training costs, to a maximum of \$5,000 per person, for training that aligns with the employer and employee needs.

What did Alliance 2030 do?

In addition, Alliance 2030 grew its membership by undertaking outreach on the SDGs through it's National Conversation Series on Canada and the SDGs. The project aimed to inform Canada's 2030 Agenda National Strategy through a Vital Signs SDGs review and report. It also evaluated the existing data landscape.
