Should Europe accept Chinese solar imports?

Why is China investing in Europe?

Europe is an important destination for some of this investment, especially for the battery industry, which is now one of the main drivers of Chinese foreign direct investment (FDI) into the European Union.

When European Commission president Ursula von der Leyen announced in September 2023 an anti-subsidy investigation into Chinese-made electric vehicles (EVs) exported to Europe, observers had mixed reactions.

Could a small supply chain reduce Europe's dependence on China?

Given the type of concerns associated with dependence on China for this

technology, maintaining a small but comprehensive supply chain within the Union could help reduce some of the risk of Europe's dependence on China even though it is unlikely to lead to a competitive domestic industry in the foreseeable future.
