#### **Overview**

What is a draft Emergency Response Plan for energy storage facilities?

This Draft Emergency Response Plan for energy storage facilities, presented by the American Clean Power Association (ACP), is the result of a collaborative member effort initially undertaken by the Energy Storage Association (ESA) in 2019 and continued following ESA's merger with ACP at the beginning of 2022.

What should be included in a construction site fire safety plan?

The Construction Site Fire Safety Plan Layout must detail how it is proposed to : - maintain effective escape widths i.e. the width of the existing door, and escape routes during each phase of the works.

How do I submit a site fire safety plan?

The Construction Phase Site Fire Safety Plan and Site Fire Safety Plan Layout must be submitted to the Approved Inspector/Building Inspector for submission to the local Fire Authority Officer and acrg the Section 8 Notification Letter.

What are the NFPA requirements for energy storage systems?

3 NFPA 855 and NFPA 70 identies lighing requirements for energy storage systems. These requirements are designed to ensure adequate visibility for safe operaon, maintenance, and emergency response. Lighing provisions typically cover areas such as access points, equipment locaons, and signage.

How do you plan a fire?

Planning for fire must be an integral part of overall preparation and budgeting for the efficient running of construction projects. Clear procedures and standards must be laid down at the start and adequate resources, in terms of time, materials and money must be committed to the prevention of fires.



What are the requirements for a battery energy storage system?

The requirements of this ordinance shall apply to all battery energy storage systems with a rated nameplate capacity of equal to or greater than 1,000 kilowatts (1 megawatt).


