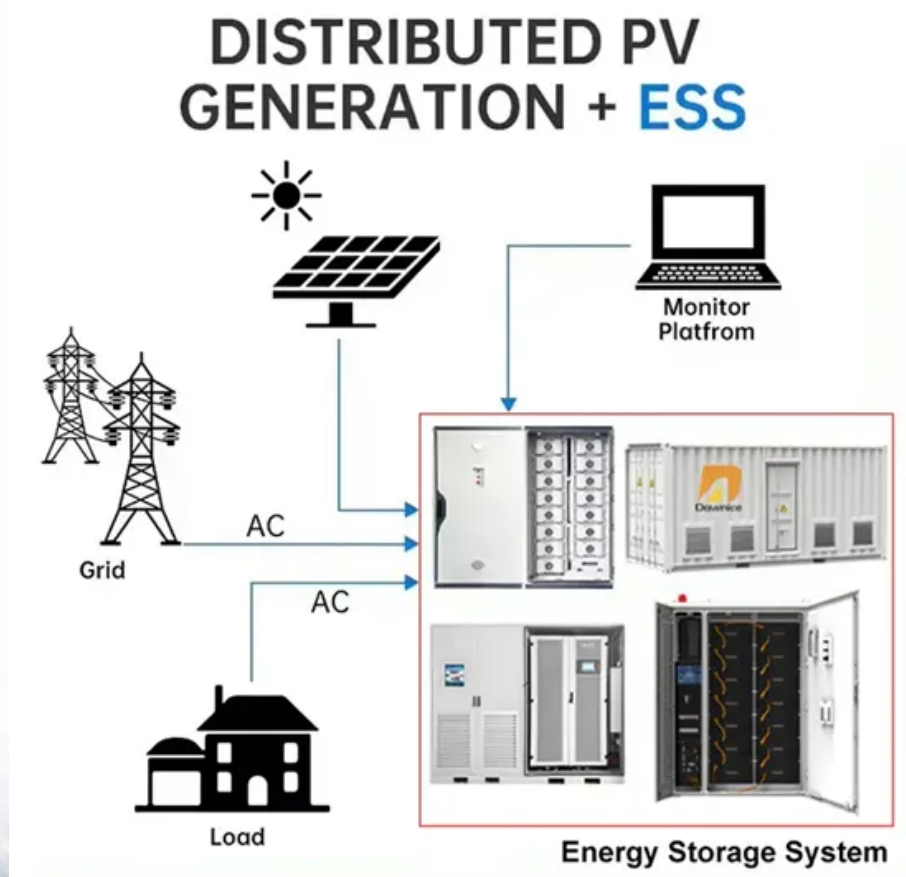

What are the benefits of investing in Panama?

Entities that carry out a minimum investment of \$2 million in Panama enjoy the benefits of legal stability and investment protection, with national, municipal, and customs tax incentives and legal stability in the labor regime for a period of 10 years.

How many free trade agreements does Panama have?

Panama is a signatory to several agreements and bilateral investment treaties in which binding international arbitration of investment disputes is recognized. Panama has a total of 14 free trade agreements, including with Singapore, Peru, Central America, Mexico, South Korea, and Israel, as well as the TPA with the United States.

Who regulates the securities market in Panama?

The Superintendency of the Securities Market is generally considered a

transparent, competent, and effective regulator. Panama is a full signatory to the International Organization of Securities Commissions (IOSCO). Relevant ministries or regulators oversee and enforce administrative and regulatory processes.
