

Norway offers a dual-track system for challenging procurement decisions:  
Complaints to the contracting authority: Possible until contract signing.  
Norwegian Complaints Board for Public Procurement (KOFA): An administrative body issuing advisory opinions, with power to fine for illegal direct awards.

How do citizens participate in procurement processes in Norway?

Norway's legal and regulatory and policy framework enables citizens to participate during the different phases of a procurement process. There is ample evidence for direct participation of citizens in procurement processes through consultation, observation, and monitoring.
