## Government procurement price of grid tied storage system in Ireland





#### **Overview**

What is the electricity storage policy framework for Ireland?

In line with CAP Action EL/24/16, the Electricity Storage Policy Framework for Ireland (ESPF) was published by my Department in July 2024. The policy framework included 10 Government actions to support the role of electricity storage systems in Ireland's energy transition.

What is EirGrid's long duration energy storage (LDEs) procurement mechanism?

In line with Action #6, EirGrid, in conjunction with the Regulatory Authority, are developing a procurement mechanism for long-duration electricity storage, through their Long Duration Energy Storage (LDES) product. The LDES product is in its initial stages with 2 separate public consultations expected in 2025 and 2026.

Should 'long duration' electricity storage systems be integrated into Ireland's Electricity Grid?

In this regard, greater emphasis is placed on ensuring 'long duration' electricity storage systems – systems that have the capacity to deliver electricity throughout at least a four-hour period – are integrated into Ireland's electricity grid.

When will long duration energy storage be available in Ireland?

The Irish Electricity Storage Policy Framework, published after this data was collected, indicates that an immediate route to market for 500 MW of long duration energy storage is currently being developed, with further studies planned to support long duration storage from 2030 to 2040 (Government Of Ireland 2024a).

Does energy storage need a new procurement framework?

A recent report by the storage industry representative organisation, Energy



Storage Ireland, has emphasised the need for a new procurement framework for long duration energy storage in particular, and for co-ordinated strategy and stakeholder engagement with regulatory bodies, policymakers and industry (Energy Storage Ireland, 2022).

What is Ireland's energy transition policy framework?

The policy framework included 10 Government actions to support the role of electricity storage systems in Ireland's energy transition. Actions #6 to #10 of the policy framework are designed to stimulate the development of the optimum level of electricity storage systems, including Long Duration Electricity Storage on to the grid network by 2040.
