What is France's plan batteries?

In 2018, France launched the Plan Batteries, subsequently extended by France 2030, aimed at accelerating the development of a national battery industry. This ambitious strategy has enabled France to attract investment for six gigafactories: ACC, Envision, Verkor, Prologium, Tiamat and Blue Solutions.

When did ipcei batteries get funding?

For projects supported under one of the two IPCEI Batteries (and other projects), the aid was approved by the European Commission over a period from December 2019 to November 2023. For the other projects, the expenditure was incurred from June 2021 to January 2024 under the France 2030 investment program.




