Under the Energy Savings Scheme Rule, we set out targets for energy retailers and large energy users. These targets are met by creating or buying Energy Savings Certificates (ESC). Energy Savings Certificates are created for eligible activities that reduce energy usage, such as installing energy-efficient appliances.

How often do you review the energy savings scheme?

We review the Energy Savings Scheme every 5 years. During the 2020 review we increased the energy savings target of the scheme by 0.5% each year from 2022, reaching 13% in 2030. The target will then remain at 13% until the end of the scheme in 2050. Find out more about the Energy Savings Scheme.

How much value does Commonwealth Procurement offer SMEs?

While the value in overall Commonwealth procurement increases, the

proportion of value has remained consistent when compared to the total value awarded. The Commonwealth awarded 43,642 contracts to SMEs representing 52 percent of contract volume. SMEs won 2,301 more contracts than compared to 2018-19.
