

# Government procurement price of solar storage inverter in Switzerland





#### **Overview**

Who surveys the solar market in Switzerland?

The Swiss Federal Office of Energy has been surveying the solar market in Switzerland for more than 20 years. Due to this long experience, the quality of the data has been maintained, thanks as well to all the installers and distributors who are willing to complete the annual questionnaire.

Can solar energy be used in Switzerland?

Although the proportion of solar heat to overall consumption in Switzerland is still relatively low, its potential is considerable. If all existing buildings were to be optimally improved in terms of energy efficiency, it would be possible to meet the heating requirements of all Switzerland's households through the use of solar collectors.

Is there a tendering scheme for PV systems in Switzerland?

There are no tendering schemes for PV systems in Switzerland. There are, however, several auction platforms for selling/buying green certificates (guarantee of origin). The price for those certificates has constantly dropped over the past years. There are no specific utility-scale measures in place in Switzerland.

What is Switzerland's government procurement platform?

Switzerland's official platform for government procurement is simap.ch, a centralized repository for tenders from the federal government, cantons, and communes. The platform provides access to a wide range of procurement opportunities, including construction projects, goods, and services.

How much support does SFOE provide for Photovoltaics Research in Switzerland?

On average, the volume of the SFOE programme support (including pilot and demonstration) is in the order of 10% of the total public support for



photovoltaics research in Switzerland, which is in the order of 36 MCHF per year (including roughly 30% from European projects) (https://pv.energyresearch.ch/projects).

How big is the PV and solar thermal market?

The data is based on a survey amongst 307 companies active in the PV and solar thermal market. About 95% of installers, importers/distributers and manufacturers are estimated to be covered in this annual market survey The added PV capacity in 2020 reaches 475 MWp, representing an increase of close to 50% compared to 2019 with 325 MWp.
