Overview

How does a PPA affect a power plant?

Sale of capacity and energy - the PPA may require the project company both to make available to the purchaser an agreed level of capacity at the power plant and deliver the energy generated in accordance with its provisions.

What is a power purchase agreement (PPA)?

Power Purchase Agreement (PPA) - short-form agreement developed for small scale power projects in Namibia Standard short-form power purchase agreement developed for small scale power projects in Namibia. This is part of a suite of documents including a fuel supply agreement that can be found on the Namibian Electricity Control Board.

What is a power plant availability charge?

an availability or capacity charge, which is payable by the offtaker in consideration of the power plant operator making generation capacity available to the offtaker, whether or not it actually offtakes electricity from the power plant.

What are the requirements for synchronization of a battery energy storage project?

4.7.1 Prior to synchronization of the Project, the BESSD shall be required to get the Project certified for the requisite test including for safety as may be laid down by Central Electricity Authority or an agency identified by the central government to carry out testing and certification for the Battery Energy Storage projects.

Who buys battery energy storage capacity from bessd?

F. SECI has agreed to purchase such Battery Energy Storage Capacity from the BESSD as an Intermediary Procurer and sell it to Buying Utility / Entity on back-to-back basis as per the provisions of the RfS.

How battery energy storage capacity is allocated under RfS?

4.3.2 Battery Energy Storage Capacity procured from the Project awarded under the RfS shall be allocated on back-to-back basis to the Buying Entities at the discretion of SECI, in consultation with Buying Entities. (To be deleted in case of a single Buying Entity for the entire awarded capacity under the RfS).

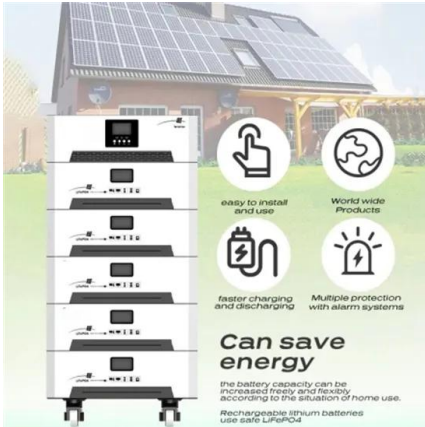
