

SEOUL, March 25, 2025 - LG Energy Solution announced today that it has signed an agreement with PGE, Poland's largest energy sector company, to supply 981MWh of grid-scale ESS batteries between 2026 and 2027. The Korea-headquartered lithium-ion OEM made its own announcement yesterday (24 March), saying it would supply 981MWh of grid-scale ESS batteries between 2026 and 2027, indicating a 9% overbuild relative to the nameplate capacity.
