#### **Overview**

What is China's new energy storage development plan?

On March 21, the National Development and Reform Commission (NDRC) and the National Energy Administration of China issued the New Energy Storage Development Plan During China's "14th Five-Year Plan" Period. The plan specified development goals for new energy storage in China, by 2025, new.

What is the implementation plan for the development of new energy storage?

In January 2022, the National Development and Reform Commission and the National Energy Administration jointly issued the Implementation Plan for the Development of New Energy Storage during the 14th Five-Year Plan Period, emphasizing the fundamental role of new energy storage technologies in a new power system.

When will new energy storage development be introduced?

The commission said earlier it will introduce a plan for new energy storage development for 2021-25 and beyond, while local energy authorities should also make plans for the scale and project layout of new energy storage systems in their regions.

How can the government support research and development in energy storage technologies?

To address the need for long-term research and development in energy storage technologies, collaboration between academia and industry will be necessary. The government may establish a Nodal Agency to coordinate R&D efforts in the field, and funding will be provided through this agency.

Why should India invest in energy storage systems?

6.11.1. India's surge in energy demand and rapid shift towards renewable energy sources offers opportunities for emerging Energy Storage System (ESS) technologies. Domestic innovation and manufacturing of ESS



technologies can stimulate job creation, economic growth, and position India as a global leader in sustainable and low-carbon energy systems.

How much storage capacity should a new re project have?

6.5.1. In order to ensure adequate storage capacity to supply reliable power, new RE projects (excluding Hydro Projects) with an installed capacity of over 5 MW or as specified by the Central Government may be mandated to install ESS (of at least 1 hour storage) for minimum 5% of the RE capacity.
