#### **Overview**

Does Poland support dynamic electricity pricing?

In summary, Poland's legal and market framework in 2025 fully supports dynamic electricity pricing, making it one of the first in the region to roll this out at scale to households, in line with broader EU energy market integration goals. By law, all large energy suppliers in Poland must offer dynamic pricing contracts as of 2024.

How does a supplier buy electricity in Poland?

In a competitive market, suppliers buy electricity on the Polish Power Exchange (TGE) or via bilateral contracts and then sell it to consumers. For most customers, the energy price portion has traditionally been a fixed rate per kWh (often set in a supplier's tariff or contract).

What is the purpose of electricity storage reform?

The objective of this reform is to facilitate the development of electricity storage by creating the necessary legal framework.

Why is EV charging exclusion a problem in Poland?

This exclusion raises concerns about the program's budget utilization and the broader development of electromobility in Poland. Another pressing issue is the expansion of EV charging infrastructure, which remains insufficient to meet the rising demand from an increasing number of electric vehicles entering the market.

Does Poland need to reduce its coal consumption & accelerate decarbonization?

Poland is facing growing pressure to reduce its coal consumption and accelerate decarbonization efforts, both on the EU and national level.

Does Poland have a price cap?



That mechanism expired in July 2024. For 2025, Poland moved to a simpler universal price cap system. From 1 January 2025 through 30 September 2025, household electricity prices are capped by law at 0.50 zł/kWh net (500 zł/MWh). This equates to 0.62 zł/kWh gross (including VAT and excise).




