

## Solar Inverter project financing options in Portugal 2026



## Overview

What is the future of solar energy in Portugal?

Solar energy is central to Portugal's renewable strategy. The solar market is projected to grow at a compound annual growth rate (CAGR) of over 6.5% from 2024 to 2029, driven by rising energy demand, reduced dependence on fossil fuels, and declining solar PV system costs.

Will BNZ roll-out solar power in southern Europe by 2026?

This is the first tranche of a €500 million loan approved by the EIB to support BNZ's roll-out of 1.7 GW of solar photovoltaic power in Southern Europe by the end of 2026. BNZ is an Independent Power Producer (IPP) that develops, builds, and operates solar photovoltaic projects, and is owned by Nuveen Infrastructure.

The European Investment Bank (EIB) and BNZ have signed a €166 million loan to support the deployment of 17 solar photovoltaic plants across Spain, Italy and Portugal. This is the first tranche of a €500 million loan approved by the EIB to support BNZ's roll-out of 1.7 GW of solar photovoltaic power in Southern Europe by the end of 2026.
