

## Successful bid price of domestic energy storage project in Ireland 2026



## Overview

---

The project, which secured an agreement at a clearing price of £150,000/MW, is targeting a final investment decision in 2025 for delivery by the end of 2026. These provisional results are subject to approval by the Regulatory Authorities and are expected to be confirmed in January 2025. How good is Ireland's energy storage strategy?

Which battery energy storage systems are available in Ireland?

The Kylemore Battery Energy Storage System in Dublin went into operation in 2023 and has the capability of providing 30MW of fast-acting storage. The South Wall Battery Energy Storage System went live in 2023 and has the capability of providing 30MW of fast-acting energy storage.

How much battery storage do we need in Ireland & Northern Ireland?

In 2021 energy experts Baringa estimated that to hit the 80 per cent renewable electricity targets in Ireland and Northern Ireland by 2030 we would need at least 1,700 MW of battery storage on the island of Ireland. Every battery storage project connected makes our electricity grid more secure and helps to integrate wind and solar power.

How much interconnection capacity does Ireland need?

Alternatively c.6.2 GW of interconnection capacity is needed if Ireland's battery energy storage capacity is maintained at the current operational level of c.800 MW. With peak demand of 11.3 GW the 8 GW of interconnection capacity and.

Will lithium-ion batteries meet Ireland's energy storage needs in 2035?

Lithium-ion batteries were assumed to be a key technology option for meeting Ireland's energy storage needs towards 2035, with a wider mix of technologies being deployed to achieve 2050's net zero targets.

Does Ireland need an end-to-end energy storage strategy?

Policy evolution is needed to support the development of the energy storage sector throughout the value chain, from R&D and product development through to project delivery and operation. To support this, Ireland needs an end-to-end energy storage strategy that can support the development of the sector.

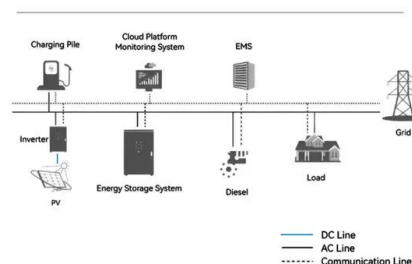
