How much does a solar plant cost in Italy?

Developers submitted maximum discounts ranging from 2.01% to 7.91% off the auction ceiling price of 0.078175 (0.084949)/kWh. The lowest accepted bid was 0.07199/kWh for a 2.7 MW solar plant in the province of Ancona, central Italy.

How much agrivoltaic capacity will Italy invest in 2026?

Under the decree, Italy plans to award a total of €1.7 billion to support commercial operations of at least 1.04 GW of new agrivoltaic capacity by June 30, 2026 (see Italy Publishes Decree For Agrivoltaic Deployment). While the previous round exceeded the capacity tendered, the funds were not exhausted.

How many solar project proposals are there in Italy?

From pv magazine Italy The first solar energy auction under Italy's new incentive scheme for renewable energy, the "transitional" FER X program, has attracted 1,387 project proposals with a combined capacity of 17,537 MW, according to Italian energy agency GSE. Prequalified project developers have until Sept. 12 to submit final offers.




