On June 20, 2024, the New York Public Service Commission approved the Order Establishing Updated Energy Storage Goal and Deployment Policy [PDF]. This Order formally expands the State's goal to 6,000 Megawatts of energy storage to be installed by 2030, and authorized funds for NYSERDA to support 200.

In 2019, New York passed the nation-leading Climate Leadership and Community Protection Act (Climate Act), which codified some of the most aggressive energy and.






